IFAP has succeeded in gaining accreditation as a trainer and competency assessor for OHS Management Systems Lead Auditors under the pre-eminent internationally recognised RABQSA Scheme.

RABQSA is a personnel and training certification body formed by an alliance between Australia and the USA.

The RABQSA Director of Certification Services, Shanya Salamaca, from the USA, conducted an examination of IFAP's competency assessment process during an IFAP internal 'pilot course' conducted in August this year.

## New Regulations for Construction Work

New regulations for the construction industry will come into effect in early 2008. These regulations are part of a national initiative for consistent laws for construction across Australia.

The new regulations introduce requirements covering:

- the provision of information;
- consultation;
- planning and documentation for construction projects.

These changes include the preparation of safe work method statements (JSAs) for high-risk construction work and the preparation of Occupational Safety and Health Management Plans for all construction sites where five or more people are working, or are likely to be working, at the same time.
